REQUEST FOR AN EXCEPTION TO WELL SPACING

ON 10 ACRES OR LESS ON MORE THAN 10 ACRES

PERMITTED WELLS REQUIREMENTS: a) Distance Requirements - 50 feet from the nearest property line and 330 feet from the nearest well; b) Distance to the property line may be decreased to a minimum of 10 feet provided the annular space between the casing and borehole is cemented from the land surface to the top of the production layer. The well shall be located a minimum horizontal distance of one hundred (100) feet from an existing or proposed septic system absorption field and fifty (50) feet from a septic tank or any water-tight sewage and liquid-waste collection facility. See Rules Section 9 - Well Spacing and Density for Detailed Requirements.

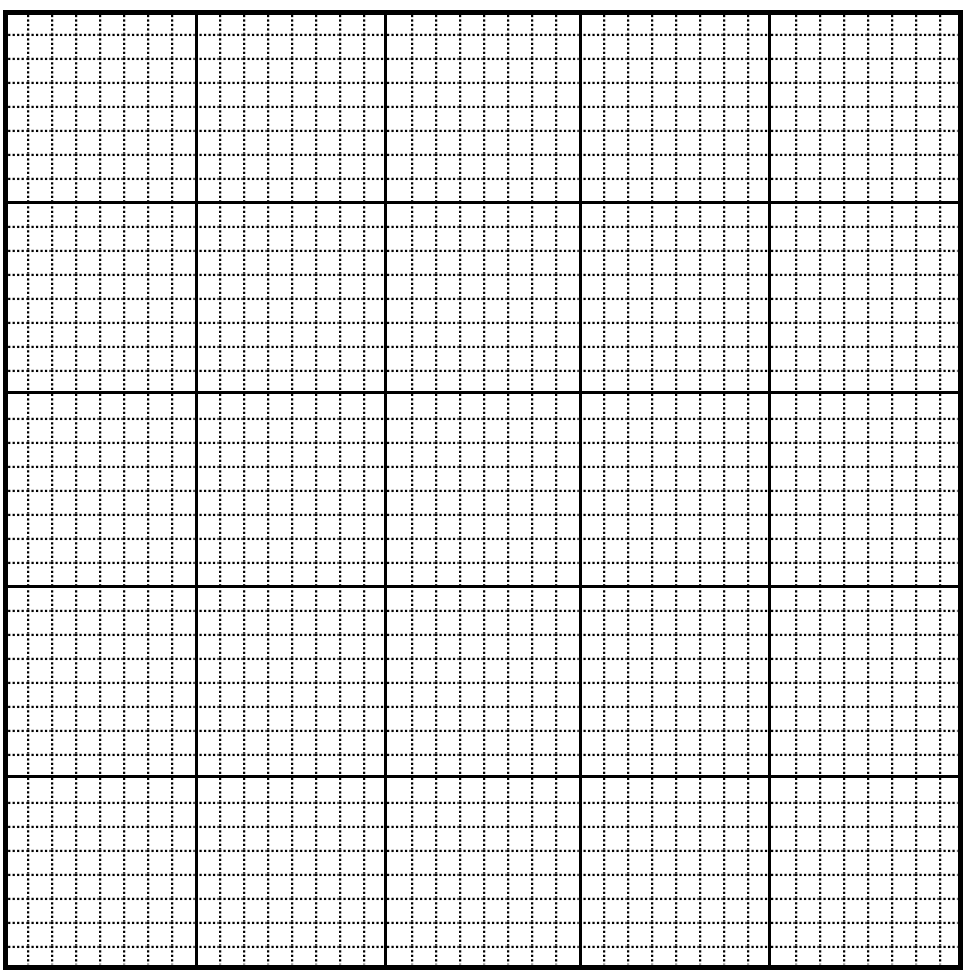
