*I agree that this well will be drilled in compliance with all District rules. I understand that this well shall be drilled **no closer than 330 feet** to an existing well or authorized well site and **not closer than 50 feet** to the property line. In the event this well is within 280 feet of the property line, then the distance between permitted wells or authorized well sites along the property line shall not be less than 660 feet and not less than 50 feet to the property line. The well shall be located a minimum horizontal distance of one hundred (100) feet from an existing or proposed septic system absorption field and fifty (50) feet from a septic tank or any water-tight sewage and liquid-waste collection facility. If the property is "Drilled to Density" and this is a replacement well, I understand that I must indicate in writing which well will be retained for production and that I must physically plug the other well within 30 days. I agree to furnish the District the completed Well Registration Report, Driller's Log, and Plugging Report, if required, immediately upon completion of this well and prior to the production of water. Failure to submit the properly completed paperwork within 6 months from the approval date of this permit or permit extension will result in the forfeiture of the permit deposit. Any change in the withdrawal or use of groundwater without having first obtained a permit amendment authorizing the change voids the permit. Violation of any provision of District Rules may result in the District enforcing these rules by injunction or other appropriate remedy in court and may result in civil penalties not to exceed \$10,000 per occurrence per day as provided in Chap. 36.102, TWC.*
