**Well Use Change - Non-Exempt to Exempt**

I understand and agree that since the property is Drilled to Density, I must either plug a non-exempt well or Request an Exception from the District Board of Directors to consider a Change of Well Use application in order to obtain a permit to drill a replacement well.

**Property Not Drilled to Density**

**Well Use Change - Exempt to Non-Exempt**

I understand and agree that an exempt well must comply with the District Rules for Spacing and Density for the District to consider a Change of Well Use application.

**Well Use Change - Non-Exempt to Exempt**

I understand and agree that for property that is Not Drilled to Density, the well must be either plugged, capped, or equipped so that it cannot produce more than 25,000 Gallons per Day.

**Violation of any provision of the District Rules may result in the District enforcing these rules by injunction or appropriate remedy in court and may result in civil penalties not to exceed \$10,000 per occurrence per day as provided in Chap. 36.102, TWC.**
